**FINDINGS AND DECISION**

The duly constituted Electoral Board, consisting of the Board of the Election Commissioners for the City of Chicago, Commissioners Marisel A. Hernandez, William J. Kresse and June A. Brown, organized by law in response to a Call issued by Marisel A. Hernandez, Chair of said Electoral Board, for the purpose of hearing and passing upon objections (“Objections”) of MARIO COLLIER (“Objector”) to the nomination papers (“Nomination Papers”) of WAYLAND C. JOHNSON JR., candidate for election to the office of REPUBLICAN Party Ward Committeeperson, 9th Ward in the City of Chicago, State of Illinois (“Candidate”) at the General Primary Election to be held on Tuesday, March 19, 2024, having convened on December 18, 2023, at 9:30 a.m., in Room 800, 69 West Washington Street, Chicago Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate were duly and timely filed.
2. The Electoral Board was constituted according to the laws of the State of Illinois.

3. A Call to the hearing on said Objections was duly issued by the Chair of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute, or statutory service was waived and service by email was authorized.

4. A public hearing held on these Objections commenced on December 18, 2023, and was continued from time to time. The Electoral Board assigned this matter to Hearing Officer Linda R. Crane for further hearings and proceedings.

5. The Objector and the Candidate were directed by the Electoral Board's Call to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. No Appearance was filed by or on behalf of the Objector, MARIO COLLIER. The Candidate, WAYLAND C. JOHNSON JR., filed an Appearance and appeared pro se.


6. The Electoral Board finds that on Wednesday, December 18, 2024, the Objector filed a Motion to Withdraw the Objections against the Candidate's Nomination Papers. The Electoral Board grants the Objector's Motion to Withdraw the Objections and the Objections are withdrawn.

7. The Electoral Board further finds that there are no additional Objections filed against the Candidate's Nomination Papers and, in the absence of any objections thereto, such Nomination Papers are deemed valid.


