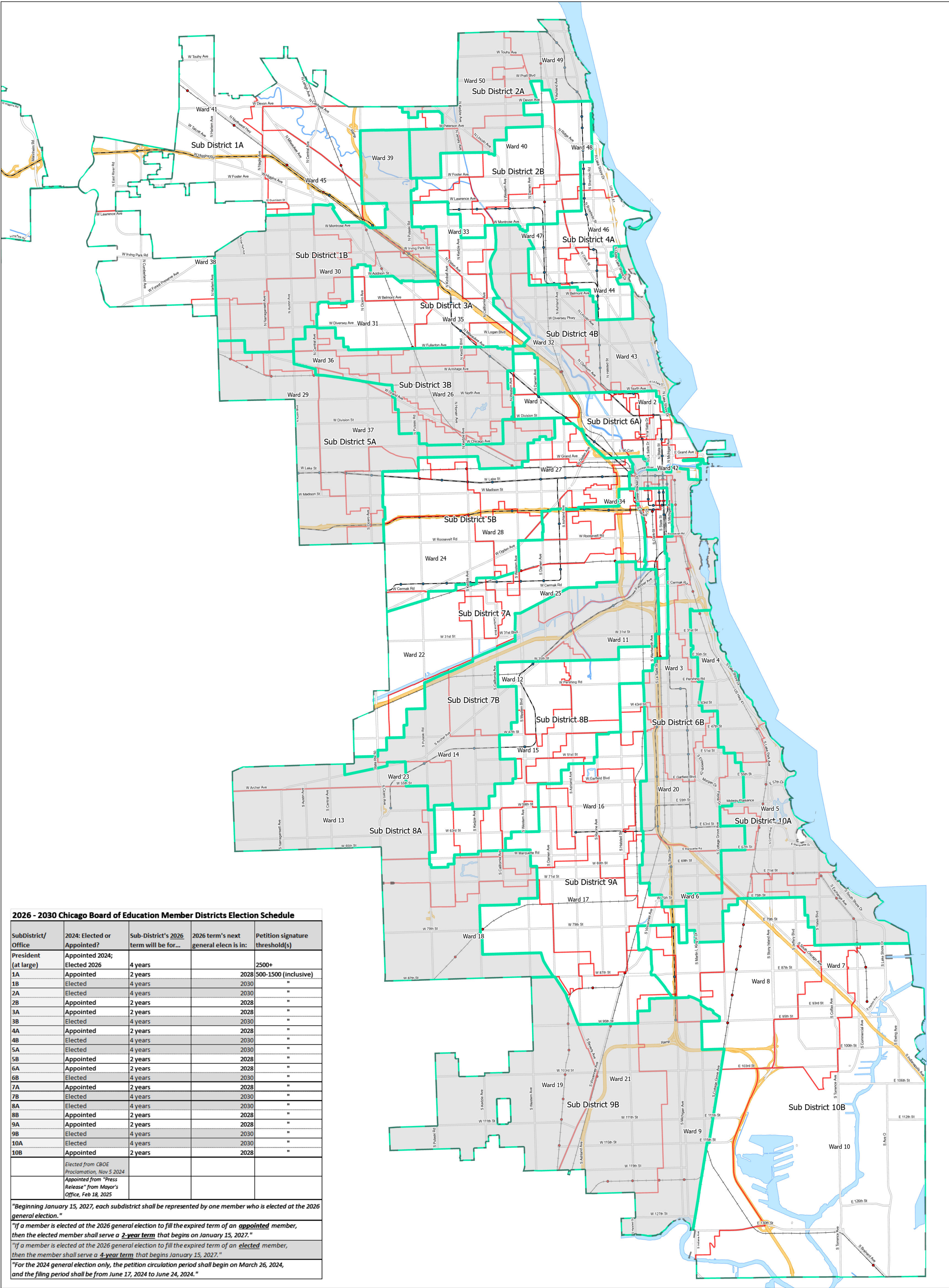

"Beginning January 15, 2027, each subdistrict shall be represented by one member who is elected at the 2026 general election."				
"If a member is elected at the 2026 general election to fill the expired term of an <u>appointed</u> member, then the elected member shall serve a <u>2-year term</u> that begins on January 15, 2027."				
"If a member is elected at the 2026 general election to fill the expired term of an <u>elected</u> member, then the member shall serve a <u>4-year term</u> that begins January 15, 2027."				
"For the 2024 general election only, the petition circulation period shall begin on March 26, 2024, and the filing period shall be from June 17, 2024 to June 24, 2024."				

CHICAGO PUBLIC SCHOOLS SCHOOL BOARD SUB DISTRICTS (2026 GENERAL ELECTION)

"Beginning January 15, 2027, each subdistrict shall be represented by one member who is elected at the 2026 general election. If a member is elected at the 2026 general election to fill the expired term of an appointed member, then the elected member shall serve a 2-year term that begins January 15, 2027. If a member is elected at the 2026 general election to fill the expired term of an elected member, then the member shall serve a 4-year term that begins January 15, 2027. If a member is elected at the 2026 general election to serve a 2-year term, then the member elected at the 2028 general election shall serve a 4-year term that begins January 15, 2029. If a member is elected at the 2026 general election to serve a 4-year term, then the member elected in that subdistrict at the 2030 general election shall serve a 2-year term that begins January 15, 2031."
